

NOTICE PASQUOTANK COUNTY

Under and by virtue of the authority vested in me by section 105-369 of the North Carolina General Statutes and pursuant to an order by the Pasquotank County Board of Commissioners I am hereby advertising tax liens for the year 2025 upon the real estate described below. The amount advertised will be increased by interest and costs and the omission of interest and costs from the amount advertised will not constitute a waiver of the taxing unit's claim for those items. The real estate that is subject to the lien, the name of the person to who owned the property on the day taxes became delinquent (January 6, 2026) and the principal amount of the taxes are set out below. If the taxes remain unpaid the lien will be foreclosed by the taxing unit and the property sold to satisfy the taxing unit's claim for taxes. These collection procedures do not apply to tax payers who may be under a current U. S. plan or who's payment due date has been extended by the law.
